- A. Public Hearing on the AMENDMENT TO BUILDING REGULATIONS OF THE CITY OF LORIS: ARTICLE II - NUISANCES

Mayor Nichols read the public notice by title only.

Clerk Kenya Wright read the Amendment to Article II - Nuisances in its entirety.

B. Public Hearing on the AMENDMENT TO ENVORONMENTAL REGULATIONS OF THE CITY OF LORIS: ARTICLE III – UNSAFE / UNFIT BUILDINGS

Mayor Nichols read the public notice by title only.

Clerk Kenya Wright read the Amendment to Article III – Unsafe / Unfit Buildings in its entirety.

PUBLIC AND PRESS COMENTS:

Mrs. Joyce Graham, writer for Tabor-Loris Tribune questioned if the revision of this ordinance would allow old trailers to be replaced with newer ones.

Mr. Harrelson responded that the ordinance currently stated that mobile homes cannot be replaced.

Mr. Scott Harper writer for the Loris Scene inquired as to if the City feared being challenged in court with residents that wish to pull in mobile homes.


Mayor Nichols states that if the issue would arise it would go through the City attorney.






