1. BUSINESS

- A. DISCUSSION AND SECOND READING OF ORDINANCE 04-24- AN ORDINANCE TO ADOPT A BUDGET FOR THE CITY OF LORIS, SOUTH CAROLINA FOR THE FISCAL YEAR 2024-2025, ENDING JUNE 30, 2025-** Meredith Holmes read the ordinance by title only. Attorney Zilinsky stated that a change needs to be made to paragraph eight, filling in the blank. He also stated that there is a typo in paragraph 10. Motion made by Councilman Padgett to adopt Ordinance 04-24 that establishes a budget for the City of Loris for Fiscal Year 2024-2025. Seconded by Councilman Hardee. All in favor. Motion passes.
- B. DISCUSSION AND SECOND READING OF ORDINANCE 05-24- AN ORDINANCE TO ADOPT A SCHEDULE OF FEES AND CHARGES FOR THE CITY OF LORIS, SOUTH CAROLINA WATER**

AND SEWER DEPARTMENT- Meredith Holmes read the ordinance by title only. Mayor Suggs stated that the fee schedule for Water and Sewer did not change from the previous budget.
