Fiscal Year 2026-2027 City Budget(s)

Pursuant to Section 6-1-80 of the South Carolina Code of Laws the City of Loris will hold a public hearing on Monday, June 29, 2026, at 6:00 P.M. The location will be at City Hall, 4101 Walnut Street, Loris, South Carolina, 29569, in City Council Chambers. The purpose of this hearing is to obtain written and oral comments from the public concerning the ordinances (04-26) establishing the Fiscal Year 2026-2027 City Budget(s) (General Fund 10, Water and Sewer Fund 20, and Hospitality Tax Fund 30).

The current proposed City millage information for these operations is as follows:

All City fee(s) are a part of the City Budget Ordinance (05-26). A copy of the City Budget Ordinance can be obtained from the Interim City Administrator's Office at Loris City Hall, 4101 Walnut Street, Loris, South Carolina, 29569. There will be changes to City Fees, a \$1 increase on all residential units in the City Budget for Fiscal Year 2026-2027 concerning Solid Waste Fees. The Budget for the City Hospitality Fund for Fiscal Year 2026-2027 is \$450,000.

The Water and Sewer Budget Fund 20 for Fiscal Year 2025-2026 was \$2,068,300.00 The Water and Sewer Budget Fund 20 for Fiscal Year 2026-2027 is \$2,070,300.00.

There will be an increase in Water and Sewer Impact Fees.

At the time and place fixed for said public hearing, all interested persons who appear will be given an opportunity to express their views for or against the ordinances (04-26) and (05-26).
