The meeting was called to order by Councilman Harrelson.

The roll was called by Clerk Kenya Wright.

COMMUNICATIONS:

MAYOR'S REPORT:

- A. Reminded that the Special Election for one open seat on City Council would be held on Tuesday, May 29th.
- B. Mrs. Samantha Norris with the Chamber of Commerce thanked the City for assisting with the Annual Spring festival held on April 21st. Mrs. Norris also advised of the upcoming first annual Yard Sale and Mess Fest.

ADMINISTRATOR'S REPORT:

- A. Advised that a budget packet would be delivered to Councilmembers by midweek for review.
- B. Advised that a check for approximately \$23,000 for road maintenance along with a check for approximately \$10,000 for the recreation department were both delivered by County Councilman Paul Prince.
- C. Advised that all Ford vehicles have been delivered. The police department vehicles have been sent out to be equipped. All vehicles will be revealed as soon as they are completely equipped at the June Council meeting.

DEPARTMENTAL REPORTS:

Departmental reports were received as information.

POLICE DEPARTMENT:

A. Introduced new police officers Niem Vaughn and Dashawn Gause. Both officer will attend the South Carolina Criminal Justice Academy in November.

BUSINESS:

A. SECOND READING OF ORDINANCE NUMBER 04-18 – AN ORDINANCE TO AMEND THE CITY OF LORIS CODE OF ORDINANCES SECTION 14 OF THE CODE OF ORDINANCES CHANGING THE DATES FOR HOLDING MUNICIPAL PRIMARIES AND ELECTIONS

Clerk Wright read the Ordinance by title only. A motion was made by Councilwoman Vescovi, Seconded by Councilman Hardee to give second reading of Ordinance Number 04-18 as presented. All members voted favorably.

B. COAST RTA RIDER SURVEY PRESENTATION - MS. MICHELLE CANTY
